JP Murphy-Town Manager- Provided Capital Improvement Projects update; Discussed award of bid for Pinellas/Ponce; should begin by end of April; change order procedures. Also discussed the award of bid for Palmetto Rd.; spoke about a possible bid protest; no action during the 10 day protest period; discussed Palmetto phase 2;

requested \$481,000 in funding from the State; Carl Ave. project and investment into the community; undergrounding.

Discussion ensued regarding undergrounding and costs.

Mr. Murphy continued to discuss CIP projects; Belleair Creek and maintenance standards.

Discussion ensued regarding maintenance issues along Belleair Creek.

Mr. Murphy spoke about the bluff walk and community forum; trimming of bluff; water fountains and benches; safety issues of some areas.

Discussion ensued regarding the condition of the bluff; regarding the land between country club and the Town.

# <u>19-0044</u> Discussion of Paver Replacement in Capital Projects

Mr. Murphy spoke about the paver replacement for roadway projects; \$44,000 for paver replacement on both projects; residents sign a indemnification agreement; never enforced; recommend to enforce the indemnification agreements; or concrete apron; Credit and replacement costs to residents; finance board said it made sence.

Discussion ensued regarding enforcing indemnification agreements for pavers; general agreement to move forward.
