A RESOLUTION OF THE TOWN OF BELLEAIR, FLORIDA, AMENDING THE BUDGET FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2018 AND ENDING SEPTEMBER 30, 2019 FOR CARRYING ON THE GOVERNMENT OF THE TOWN.
