Forward Pinellas Presentation

Whit Blanton-Executive Director Forward Pinellas-provided info on agency; spoke on Advantage Pinellas; planning for growth and corridors for redevelopment; multimodal plan; preservation of land for industrial employment areas; TEILS study to be completed by end of 2022; Alt US-19 transition plan for underutilized lands; highlighted transportation project updates; areas of highest population growth; addressed question regarding West Bay Drive resurfacing project pushed to 2023.

Commissioner Shelly questioned municipality responses to West Bay project. Mr. Blanton provided comments.

Mr. Blanton continued presentation; projects selected annually, work with local government to get funding; additional funds to be received due to federal infrastructure bill; spoke on safety; Safe Streets Pinellas program; spoke on water taxi service as an enhancement; conducting study in pedestrian crossing areas; Equity Action plan.

Commissioner Shelly requested formal letter to Senator Hooper.

Discussion of Commission Budget Priorities

Ashley Bernal-Assistant to the Town Manager-introduced new Management Analyst, Katherine Bleakly; priorities developed based on discussions with Commissioners; spoke on high priority item of financial resiliency.

Deputy Mayor Kurey wants to continue to look into creative funding opportunities; Commissioner Shelly agreed.

Ms. Bernal stated this would be for financial resiliency and would be for Town-wide funds. Mr. Murphy provided information regarding the Buff study funding and agreement with SWFWMD.

Ms. Bernal spoke on setting priorities for CIP; reinvigorating the Strategic Plan and updating the matrix; spoke on general fund and individual department items; enterprise funds; citizen satisfaction survey.

Discussion of Changes in Labor

Mr. Murphy stated Commissioner Chaney requested information on staff changes; provided historical data; provided data for government jobs in Tampa Bay region; lower wage positions are seeing competition from other markets; COVID factors as well; candidate pool is small.

Commissioner Shelly commented on other municipalities that are facing the same issue as well.

Commissioner Chaney questioned if exit interviews are done and if employees have taken advantage of them. Mr. Murphy stated that exit interviews were offered; most had participated but not all.

Deputy Mayor Kurey questioned numbers in report.

Discussion of Town Manager Performance

Meeting went into recess at 7:56 PM and resumed at 8:01 PM.

Mayor Wilkinson spoke on challenges regarding supervising a role that the commission has not performed in; questioned if there may be a culture concern; seeking way to address.

Commissioner Shelly stated annual performance review is done in May; COVID created shortfalls everywhere; staffing and cross training difficulties in a town this size.

Commissioner Nessler spoke with staff, questioned if there is a culture issue; general consensus of staff very supportive; pandemic has taken a toll on everyone.

Deputy Mayor Kurey questioned the turnover numbers; suggested having a third party evaluate whether there is a culture issue; attorney could bring some ideas and potential firms in to investigate.

Commissioner Chaney stated she has not received supportive feedback; spoke on former attorney; transparency with process; succession planning; institutional knowledge.

Mr. Murphy spoke on advisory board trainings that have been done; organization chart restructure is a step at succession planning; discussed milestone program for employees; policy updates that have been done; COVID impacts and stressors with extra workloads; discussed an extensive list of items achieved by staff in response to question of what has been done over the past five years.

Discussion ensued regarding hiring a consultant; work place culture; issues with turn-over.

Patricia Irwin-resident-spoke on looking at patterns.

It was the consensus of the Commission to allow the town attorney to hire a workplace culture consultant by next meeting or sooner.

Ms. Rettstatt-spoke on consultant being off premise.

Deputy Mayor Kurey move to do an evaluation of workplace culture at Town of Belleair and to have the town attorney bring suggestion no later than next meeting some suggestions and firm to hire and that the firm have unfettered access to employees, former employees, commissioners and to whoever they feel is relevant. Seconded by Commissioner Shelly.
