
- 2 additional enhanced practice greens

- Additional maintenance building















Existing Zoning: Single Family Residential (R-1)




Proposed Zoning: Golf Course District (GC)




Note: Rezoning includes vacated right-of-way

- Request to vacate portions of Althea Road and Golfview Drive
- Replaces with cul-de-sac
- Roadway not needed with adjacent parcel change
- Pedestrian Sidewalk and Easement from Golfview to IRR.
- Received petition in support from neighbors on roadway.
- Town received charter compliant appraisal











- Request is to add guest cottages as an accessory use to the Golf Course zoning district.
- Temporary living and sleeping quarters for exclusive use of members and sponsored guests
- Max # Bedrooms: 8
- Minimum Dimensions of 3,000 sq ft
- Bedroom Minimum of 300 sq ft
- No kitchen or cooking facilities
- No other transient rentals, Not to be offered by 3rd party booking sites, fees to be billed and paid by sponsoring member
- Maximum length of stay shall be one week for any group.

- Proposed Cottages
- Two, 2-story cottages each 3,800 sq ft
- 4 Bedrooms each floor
- Roof height of 28 ft.
- Common living areas with TV and Library areas
- Single, Common keyed entrance.
- Exterior architecture of the structures will match the Clubhouse and Grill Room / Pro Shop
