JP Murphy-Town Manager-Noted a change in staff requires update.

Mr. Murphy briefly discussed purpose for amendment.

Stefan Massol-Director of Support Services-Provided update regarding anticipated FEMA reimbursement from Hurricane Irma; estimated cost recovery to be 80-90%.

Mr. Murphy discussed the ABM program as it relates to amendment as well as capital projects; addressed questions relating to future budget inscrease for Harold's Lake maintenance.

Eric Wahlbeck-Director of Parks and Recreation-Answered questions relating to Prime-Scape; recommends awarding bid.

Deputy Mayor Rettstatt moved approval of award of bid for 2017-18 maintenance of urban canopy to Prime-Scape Services; seconded by Commissioner Wilkinson.

Mr. Murphy detailed area and scope of clean out; potential for future maintenance agreements with Gatehouse Woods.

Deputy Mayor Rettstatt provided details of scultptures; azalea to be in memorial of Weiss family; BCF Board of Directors selected designs;

Nancy Hartshorne-Resident-Questioned location of kinetic art.

Deputy Mayor Rettstatt stated a drinking fountain will be added as well; pavers honoring pets to be included.

Commissioner Wilkinson moved approval of artwork for Magnolia and Wall Park; seconded by Commissioner Kurey.

<u>18-0016</u> Discussion of Consolidating the Park and Tree Board and Recreation Board.

Mr. Murphy stated item previously discussed; low frequency of meetings; all members previously set to expire same time; more direction to boards if not consolidated; seeking input.

Mayor Katica is opposed to consolidation.

Nancy Hartshorne-Park and Tree Board member-Commented that not all members may have interest in both areas.

Lil Cromer-Park and Tree Board member-Spoke on addition of duties to board members.

Discussion ensued regarding upcoming park renovations; need for clearer direction to boards coming from Commission; consensus that consolidation would be premature; stagger term limits again in May; inviting board members to upcoming meetings to discuss role and expectations.

### TOWN MANAGER'S REPORT

Mr. Murphy announced volunteer reception March 16th for board members; April 3rd-6th is the TLG Conference, suggests cancelling April 3rd meeting, consensus to cancel; work being done along Belleair Creek; commented briefly on upcoming projects; seeking to obtain a civic center alcohol sales permit in order retain funds raised at events, consensus to pursue.

#### TOWN ATTORNEY'S REPORT

David Ottinger-Town Attorney-Nothing to report; commented on successful race event.

#### MAYOR AND COMMISSIONERS' REPORT/BOARD AND COMMITTEE REPORTS

Chief Sohl commented on Belleair Officers providing off duty services in conjunction with Clearwater Police and Pinellas County Sheriff; provided crime updates and traffic enforcement statistics from January; discussed code enforcement projects being worked on; look, light, lock initiative success.

Mayor Katica-Nothing to report; commented on noise on street.

Commissioner Kurey-Commented on setting objectives and measurable goals for the year.

Deputy Mayor Rettstatt-Spoke on success of the race; would like to obtain price of underground utilities and status of water; analysis of recreation events; questioned trees marked; suggests holding a hurricane preparedness event; attended Forward Pinellas meeting regarding West Bay bike lanes; possible addition of a community board with project information.

Mr. Murphy addressed tree question; Belleair Bluffs will be hosting a preparedness event and have extended the invitation; will have an agenda item regarding short term objectives.

Commissioner Wilkinson-Recreation Board didn't meet; race was a success; upcoming flag football; thanked donors for score board; concert this Sunday.

Commissioner Shelly not in attendance.
