## NOTICE OF SPECIAL MAGISTRATE HEARING

Notice is hereby given that a Public Hearing will be held before the Special Magistrate of the Town of Belleair, Florida on requests for variances to the Code of Ordinances, Article II, Section 74-84, of the Land Development Code, for the property located at 8 Westwood Lane, Belleair, Florida (Parcel No. 28-29-15-07164-000-0130, as recorded in Plat Book 61, Page 40 of the public records of Pinellas County, Florida). The variance requests are specifically enumerated below.

Variance 1: The applicant is requesting a variance from the minimum 25ft front yard setback requirement for the construction of an addition, resulting in a 12ft 8in front yard setback from property line arc, or 4ft 11in from property line chord.

Variance 2: The applicant is requesting a variance from the minimum 20ft or 20 percent of the lot depth, whichever is less, rear yard setback for the construction of an addition, resulting in a 14ft 6in rear yard setback.
