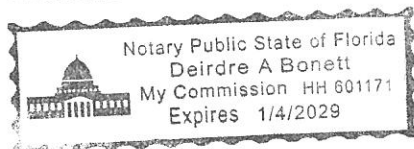

**ORDINANCE NO. 584**

**AN ORDINANCE OF THE TOWN OF BELLEAIR, FLORIDA, AMENDING CHAPTER 2, ARTICLE II, DIVISION 1, SECTION 2-41 OF THE TOWN CODE TO PROHIBIT REMOTE ATTENDANCE BY MEMBERS OF STANDING OR TEMPORARY SUBORDINATE ADVISORY OR QUASI-JUDICIAL BOARDS; MAKING RELATED FINDINGS; AND PROVIDING FOR CODIFICATION, SEVERABILITY, AND AN EFFECTIVE DATE.**
