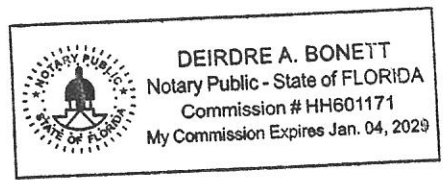

ORDINANCE NO. 595

AN ORDINANCE OF THE TOWN OF BELLEAIR, FLORIDA, REPEALING CHAPTER 23 OF THE TOWN CODE RELATING TO COMMUNICATION SYSTEMS IN RIGHTS-OF-WAY AND § 62-1 OF THE CODE RELATING TO UTILITY SYSTEM COMPONENTS; CREATING A NEW CHAPTER 61 OF THE TOWN CODE CREATING RIGHT OF WAY USE REGULATIONS; MAKING RELATED FINDINGS; PROVIDING FOR SEVERABILITY, CODIFICATION, AND AN EFFECTIVE DATE.
