

GENERAL AGENDA

<u>16-0224</u> Biltmore Project Update

David Healey-Calvin Giordano and Associates-Provided an overview of the Belleview Biltmore Development; detailed the master plan schedule and four year build period; demolition permit 95% complete; new entry road and underground utilities are complete. Construction on first carriage home to begin this month; condo construction to begin November; section of hotel will be moved in December.

Mr. Healey identified provisions for the hotel including tiffany glass, ice cream parlor, grand stair and lobby; two main changes are the addition of two rooms to the inn and developers retaining south porch instead of west porch. Annual review finds terms of the development agreement are being met; project to be completed in phases with final completion in December 2020.

Discussion ensued regarding sign placement; addition of rooms to inn.

OTHER BUSINESS

Ms. Gaston updated the board on the status of the archives; board members welcome to view items at any time.

COMMISSION ADVISOR REPORT

Commissioner Kurey commented on Mr. Healey's retirement and thanked him for his years of service to the Town; Chairman Hutcheson thanked him as well.

Commissioner Kurey commented on recent variances and board recommendations. Also briefly discussed the golf course purchase negotiations; buyer seeking site plan approval prior to purchase; a complete site plan is still needed; current contracted closing date is late 2016, early 2017; extensions will be needed as site plan review will proceed beyond that.

Discussion ensued regarding appraisal amount; current lease; conservation easement provision; Town's potable water wells on golf course property. Commissioner Kurey noted all items are part of negotiation process.

Further discussions regarding drainage on Althea Rd.; site plan application process; potential use of property; term of lease; objective to remove development rights and establish conservation easement; public versus private course.

Historic Designation - Lighting system

Summary:

Discussion about the creation of a historic lighting district **Previous Commission Action:** None

Background/Problem Discussion:

For decades the Town of Belleair has maintained a whiteway system supported by 12 foot concrete poles. In 2010, the town began to expand the number of whiteways within the town by adding additional poles and lighting that matches the old system, while also upgrading the electrical wiring. In order to recognize and protect the historic nature of this system, staff is recommending that a historic street lighting district be created within the town. Among other thing, the lights within the district would be eligible for grant funding through the certified local government program, and the Town would have the ability to limit or eliminate the types of items attached to the poles.

The towns historic preservation code requires that a nomination be filed with the town manager by the property owner, a members of the historic preservation board, or a member of the town commission. Once a nomination is made, the town commission would be noticed and the historic preservation board would hold a public hearing within 60 days of the application being filed. Based on that meeting the historic preservation board would generate findings based on evidence provided and make a recommendation to the town commission. That recommendation would then come forward to the commission, who would decide whether or not to pass an ordinance designating the structure.
