<u>18-0241</u> Discussion of 18/19 Capital Budget and CIP

Commissioner Kurey introduced Gayle Grady as Board Consultant, provided background.

Gayle Grady-works for American Consulting, discussed experience in construction field.

JP Murphy-Town Manager-Stated staff previously evaluated drainage conditions of roadway segments along with areas of significant safety and lighting concerns; this was previously identified as Plan 2; inflation and construction costs required plan revision; commission tentatively approved 6.5 mil tax rate; discussed revenue streams and debt service.

Discussion regarding difficulty estimating too far out; methodologies for segmenting larger projects; availability of SWFWMD funding; potential Local Agency Program (LAP) funding available.

Mr. Murphy continued discussing specific roadway projects to be completed in the upcoming year; cost for bluff is estimate, study needed; areas of flooding, ponding, and poor drainage.

Keith Bodeker-Construction Project Supervisor-Discussed drainage and collection along roadways.

Mr. Murphy continued project discussion; potential for one-way traffic and parking around Magnolia/Wall Park area; seawall replacement in years 6 and beyond, and minor roadway improvements; Belleair Creek Phase I and II projects in past and potential for joint project with Pinellas County and Largo; Mr. Bodeker commented on sanitary sewers in area; Deputy Mayor Rettstatt commented on the county lift station and problems with raw sewage in area.

Mr. Murphy hopes to work with Country Club architects regarding sump pump, using water for irrigation, decreasing sediment into Harold's lake.

Discussion regarding rebids of Pinellas/Ponce and Palmetto projects, anticipated start dates; projects had to be segmented due to costs; discussion of funding sources.

Mr. Murphy briefly discussed Ahlf properties; finalized CIP presentation; addressed questions from the board; roadway projects and drainage; speed limits; traffic on Indian Rocks Road; water system and well issues.

Mr. Murphy stated he was looking for recommendation for commission to approve 2018-2019 capital budget and the tentative 5 year CIP plan.

Mr. Foley moved to approval the recommendation; seconded by Mr. Oder.

#### **Summary:**

Staff is seeking Commission approval to apply Reclamite Asphalt Rejuvenating Agent within the roadways noted in this submittal. The areas noted are from the previously completed capital improvement projects of Eagles Nest Dr and Druid/Corbett St.

**Previous Commission Action:** N/A

**Background/Problem Discussion**: The Eagles Nest Dr and Druid/Corbett St projects were completed five years ago. In an effort to help extend the life and longevity of the asphalt roadways within those project limits, town staff is recommending application of this Reclamite Asphalt Rejuvenating Agent. This Reclamite application will help restore necessary emulsions and boding agents to the top surface of the asphalt, and extend the working life by approximately 4-5 years per application of Reclamite. This process can be done two or three times, depending on actual wear and use patterns of the asphalt.

The Town will be piggy backing on the City of Punta Gorda annual contract in order to obtain the unit pricing as submitted.

**Financial Implications:** The total cost of the Reclamite Asphalt Rejuvenating Agent application by Pavement Technology Inc. will be \$38,204.46.

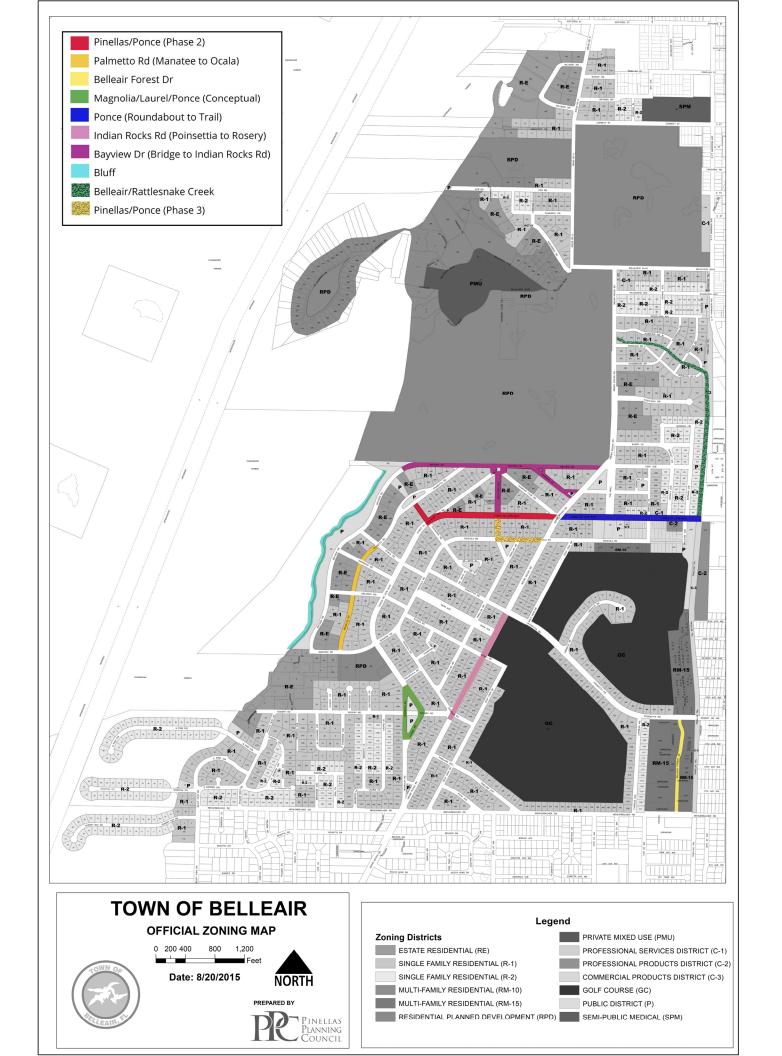

Town street lighting update and overview

#### **Summary:**

Town staff has been working tirelessly on several aspects of street lighting within Town limits over the last year. These have been some much needed upgrades and improvements, but there is still a lot of work yet to be done. One of the upgrades that have taken place is replacing existing direct buried wire for the decorative street lights. Staff is having 1" conduit installed to each of the decorative street lights, with new wiring installed inside the conduit. This has been a huge help in supplying a more consistent power supply to the lights. To date we have been able to successfully complete all replacements from Park Ave south to Mehlenbacher Road on the west side of Indian Rocks Road.

Another upgrade that staff has worked on is updating all of the Duke lighting from high pressure sodium lights (yellow color) to LED (bright white). Town staff is still working with Duke on when the LED conversions will start, but anticipate it to be some time in Spring of 2019. Finally, staff wanted to inform the Infrastructure Board that they have been having numerous issues with the current street light supplier, Cyclone Lighting. There was a previous shipment of lights that have been found to have a "leak defect" that renders the lights useless once the lights fills up with water. The supplier has been less than forth coming in supplying replacement parts in a timely manner in order to repair them. Also, the supplier is no longer making the current style of head with LED chips in it, they are going to a solid module type. While the style change can be handled with a few minor adjustments to managing inventory, the outrageously long lead and delivery times are difficult to manage and plan for.

Staff will be exploring more options in the future to bring to this Board for their input and review. In the short term, staff has found a retrofit option to make use of the existing light fixtures and globes. We are able to

purchase the replacement bulbs directly, and in a more timely manner, to have a 5 yr warranty on them and can replace on our own. Also, the current retrofit cost is more cost effective than purchasing the Cyclone option. The retrofits have been installed on Belleview Blvd starting at Ft Harrison and heading to the west. Staff will bring examples of the deficient lights and the new retrofits to the meeting.
