ORDER FINDING NON-COMPLIANCE AND IMPOSING PENALTY/LIEN

This matter having come before the Code Enforcement Special Magistrate for the Town of Belleair on August 15, 2018, and after having received testimony from Officer Richard Doyle that the subject property was not in compliance as of July 13, 2018, and Charlotte K. LePelletier having failed to appear after receiving Notice of the Hearing, and the Special Magistrate having received into evidence the Notice of Hearing, a copy of the Special Magistrate Order dated June 18, 2018 and eight (8) photos of the subject property, it is

ORDERED that the property commonly known as 1703 Cypress Avenue, Belleair, FL 33756 is in non-compliance as of July 13, 2018 with the Town of Belleair's Code Enforcement Special Magistrate's Order dated June 18, 2018; and it is

ORDERED that the Respondent pay to the Town of Belleair a fine in the amount of \$250,00 per day for each day the violation exists and continued past the 13th day of July, 2018, the date set for compliance; and it is

ORDERED that the Respondent pay to the Town of Belleair the costs of prosecution referenced in the June 18, 2018 Order in the amount of \$708.00; and it is

ORDERED that this Order shall be recorded and it shall constitute a lien against any real or personal property owned by the Respondent and may be enforced in the same manner as a

court judgment by a Sheriff of this State, including levy against personal property, but shall not be deemed a court judgment except for enforcement purposes as set forth in Florida Statute Section 162.09
