<u>17-0189</u> First Budget Hearing - Approval of the Tenative Millage Rate for Fiscal Year 2017-2018

JP Murphy stated first of two TRIM hearings; staff recommends maintaining current rate of 5.9257; due to increase in values, represents a 5.87% increase; Commission previously approved MMP at same rate.

Tom Olson-Resident and Chairman of Finance Board-Spoke on difficulty of process; potential millage increase next year; commented on Penny for Pinellas importance.

Dan Hartshorne-Resident and Vice Chairman of Finance Board-Seconded comments made by Mr. Olson.

No further public comments to be heard.

Commissioner Shelly moved approval of setting the tentative millage rate at 5.9257, providing that the increase is 5.87% over the rollback rate; seconded by Deputy Mayor Rettstatt.
