

RESOLUTION 2025-12

A RESOLUTION OF THE TOWN COMMISSION OF THE TOWN OF BELLEAIR, FLORIDA, AMENDING RESOLUTION 2010-55 TO REORGANIZE THE DUTIES OF THE INFRASTRUCTURE BOARD AND PROVIDING FOR AN EFFECTIVE DATE HEREOF.

WHEREAS, section 2-36 of the Code of Ordinances, Town of Belleair, Florida, vests in the Town Commission the discretion and authority to create, reorganize, or dissolve standing or temporary boards or committees as it determines to be in the best interest of the Town, unless otherwise prohibited by law; and

WHEREAS, the Town Commission created the Infrastructure Board via the adoption of Resolution 2010-55 and therein assigned to it certain duties and responsibilities; and

WHEREAS, the Town Commission, upon the recommendation of the Town Manager, has dissolved the Park, Recreation, and Tree Board; and

WHEREAS, the Park, Recreation, and Tree Board was the entity designated by the Town responsible for policies and procedures relating to publicly owned trees for purposes of the Town's participation in the Tree City USA program; and

WHEREAS, the Town desires to continue its participation in the Tree City USA program and, in furtherance thereof, finds it is in the Town's best interest to reorganize the duties and responsibilities of the Infrastructure Board to add the duties and responsibilities formerly assigned to the Park, Recreation, and Tree Board relative to the Tree City USA program to the Infrastructure Board.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COMMISSION OF THE TOWN OF BELLEAIR, FLORIDA, THAT:

Section 1. Section (1) of Resolution 2010-55 is amended as follows:

(a) The Infrastructure Board shall continually review and analyze the present and future infrastructure needs of the Town, as well as short and long term infrastructure planning.

(b) The Infrastructure Board shall conduct surveys and fact-finding studies as requested by the Town Commission.

(c) The Infrastructure Board shall perform all functions of a Tree board under the Tree City USA program, so long as such duties are not in conflict with any state, federal, or local law.

(ed) All recommendations by the Infrastructure Board for action by the town shall be made to the Town Manager, who in turn shall furnish such reports to the Town Commission.

Section 2. This Resolution shall become effective immediately upon its adoption.
