## **ORDINANCE NO. 583**

AN ORDINANCE OF THE TOWN OF BELLEAIR, FLORIDA, AMENDING SECTION 50-21 OF THE TOWN OF BELLEAIR CODE OF ORDINANCES TO ADD A DEFINITION FOR ATHLETIC FIELDS AND TO DELETE THE REFERENCE TO RECREATION FIELDS FROM THE DEFINITION OF PARK; AMENDING SECTION 50-22 OF THE TOWN OF BELLEAIR CODE OF ORDINANCES TO DELETE THE REFERENCE TO HOURS THAT THE RECREATION FIELDS WERE OPEN; CREATING A NEW PROVISION FOR ATHLETIC FIELDS AND OPERATIONAL HOURS AND THEREFOR THROUGH GUIDELINES THE PARKS AND RECREATION DEPARTMENT; REPEALING ALL ORDINANCES IN CONFLICT HEREWITH; PROVIDING FOR CODIFICATION; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE HEREOF.
