**TASK AUTHORIZATION FORM NO. 16
UNDER CONTINUING SERVICES WITH RS&H**

This Task Authorization is No. 16 of 16 and is made and entered into between the Town of Belleair, Pinellas County, Florida, a municipal corporation, created and existing under the laws of the State of Florida (the "Town"), and **RS&H**, a consulting firm (Consultant), with offices located at 1715 North Westshore Blvd, Suite 500, Tampa, FL, hereinafter referred to as the Consultant. **The work under this task authorization is related to Indian Rocks Phase 3 Design, previously authorized under Task Authorization No. 12 (Purchase Orders 37729, 38528, 38540 and 38660), Task Authorization No. 14 (Purchase Order ????) and Task Authorization No. 15 (Purchase Order ????)**.

RECITALS

A. The Town and Consultant are parties to a Continuing Services Agreement dated **June 3, 2019** (the "Services Agreement") for certain engineering services, pursuant to which the Town may issue multiple authorizations for specified scopes of work to be performed by the Consultant.

B. Pursuant to the terms of the Services Agreement and this Task Authorization, the Town desires to authorize Consultant to proceed on an agreed scope of work on behalf of the Town.

C. The Town and Consultant have reached agreement on the terms under which Consultant is authorized to proceed with services **more particularly outlined in Exhibit "A" dated April 25, 2024 (See attached)**.

WITNESSETH that in consideration of the mutual covenants herein contained, the parties hereto agree as follows:

1. Terms of Agreement; Scope of Work. Upon the execution of this Task Authorization by both the Town and Consultant, Consultant agrees to initiate the services set forth in the agreed Scope of Work attached hereto as Exhibit "A" (the "Services") **more particularly scope sections 3.4, 3.6, 4.10, 4.11, 4.20, 4.22, 4.23, 4.25, 4.26, 5.21, 5.28, 5.29, 23 and 24**. The Services shall be performed as set forth in this Task Authorization and subject to the terms and conditions of the Services Agreement.

2. Schedule. The schedule for the completion of the Services shall be as set forth in the agreed Scope of Work attached hereto as Exhibit "A." The completion dates are subject to change to the extent permitted under the terms of the Services Agreement.

3. Fees. The fees for the Services under this Task Authorization are based on a lump sum amount of **\$68,043.84** for the additional costs associated with providing a defined Maintenance of Traffic (MOT) Plan, Lighting Analysis / Design for Indian Rocks Road Phase III and meetings and coordination with Town staff which are beyond the original design scope and fees. All costs and design scope changes are as outlined in the attached Exhibit “A” with this Task Authorization. Payment will be made by the Town of Belleair based on monthly invoice submittals provided by RS&H which shall include pro-rated completion percentages for the various work elements under this Task Authorization along with supporting narrative of the work performed for the monthly invoice period.
