ORDINANCE NO. 582

AN ORDINANCE OF THE TOWN OF BELLEAIR, FLORIDA, AMENDING APPENDIX B – FEE SCHEDULE OF THE CODE OF ORDINANCES OF THE TOWN OF BELLEAIR TO REFLECT AN INCREASE IN SOLID WASTE COLLECTION RATES; REPEALING ALL ORDINANCES IN CONFLICT HEREWITH; PROVIDING FOR CODIFICATION; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE HEREOF.

This Business Impact Estimate is provided in accordance with section 166.041(4), Florida Statutes.  - c. Section 553.73, Florida Statutes, relating to the Florida Building Code; or
 - d. Section 633.202, Florida Statutes, relating to the Florida Fire Prevention Code.

This ordinance raises solid waste fees to increase revenue to balance the solid waste fund budget.
