Dear Ms. Lancaster:

Jones Edmunds has provided the design, permitting, and bid services for the drainage, sidewalk, and paving improvements for Carl and Shirley Avenues. Construction Contract Administration Services were excluded from the Design Services.

#### **SCOPE OF SERVICES**

Jones Edmunds will provide the following Construction Contract Administration Services:

- Submittals: Jones Edmunds will review and issue comments on project submittals.
   Project submittals will include shop drawings and product data for the materials to be incorporated into the project.
- Requests for Additional Information (RFI): Jones Edmunds will review and respond to up to five RFIs submitted by the Contractor. RFIs are submitted by the Contractor when questions about the construction documents arise that need clarification from the Engineer.
- Site Visits: Jones Edmunds will perform site visits while the Contractor is onsite working.
   The site visits are to observe that the construction is progressing in general conformance with the Construction Contract Documents.
- Review and certify monthly payment applications to the Town of Belleair. Certification
  will be based on the language included in the Contractor's pay application certificate
  (see attached).

#### PROJECT CLOSEOUT

The Project Closeout phase includes Substantial and Final Completion walkthroughs, preparation of punch lists, and review of Record Drawings.

 Jones Edmunds will provide one Substantial Completion site review and provide a punch list to the Town and the Contractor.

- Jones Edmunds will conduct one Final Completion site review to document that the Contractor has completed the punch-list items. Any additional visits to verify that the outstanding punch list items are completed may be provided by Jones Edmunds if authorized by the Town or may be performed by the Town at their discretion.
- The Contractor will prepare the Record Drawings for the project, and Jones Edmunds will review the drawings and provide comments. Deficient Record Drawings will be returned to the Contractor for correction.

#### COMPENSATION

Based on the Scope of Services described above, the Town will compensate Jones Edmunds on a time-and-materials basis up to a not-to-exceed fee of \$89,055.00. Attached is a detailed Fee Estimate. The fee is based on a budget of 70 site visits during the course of the project; however, we will only bill for the actual number of visits and hours expended on the project.

#### **CLARIFICATIONS**

- Onsite coordination with residents is excluded.
- The Town will review and issue any change orders, construction field orders, and proposed contract modifications.
- Jones Edmunds will not attend progress meetings (unless they are on the same day as the site visits).
- The expected hours listed in the attached Fee Estimate are intended as documentation and justification for the total cost of the project. Deviations or changes in the hours or costs within a task or between tasks shall not be reason for nonpayment if the total project cost has not been exceeded.
